CHAIRMAN'S FOREWORD

It is my pleasure to report on another successful year for University Hospitals of North Midlands Charity. Charities have existed in the NHS since the day it was created, now more than 70 years ago. In that time these charities have supported NHS staff to provide a level of care and patient experience that otherwise just wouldn't have been possible.

UHNM Charity is part of the fabric of our hospitals. Often there is a very personal reason why people give money to the NHS, be that the care of an elderly relative, the support staff have given bringing a new life into the world or simply just being there when you needed us. On occasion there is no reason other than the respect the nation has for its health service and the motivation to give something back.

It's not just those who use or admire the services that give to UHNM Charity. Many of our 11,000 staff fundraise throughout the year because they have identified specialist equipment or enhanced services that can make a real difference for their patients. The Charity also runs specific appeals for particular items such as the beautiful Oncology, Haematology and Chemotherapy garden, which will open at County Hospital in 2019.

Behind everything that UHNM Charity does, whether that involves contributing to enhanced staff training and education or buying very specialist equipment, is a commitment that it will make a positive difference to our patients.

With that degree of commitment comes a level of responsibility to ensure that the funds you and your family raise for the NHS are both well managed and

well spent. This report provides detailed information about this and you can find out more about our activities on our website.

You will also find inspirational stories about fundraisers and how they have made a difference. For example, Jane and Gareth Kent, who raised money for Critical Care in recognition of Jane's many weeks of treatment on the unit following a number of cardiac arrests, or Antony Perrins, who ran 100,000 metres for Neonatal Intensive Care after his son Oliver spent 81 days on the unit.

I want to say a huge thank you to all our inspirational fundraisers on behalf of the Trustees, everyone who works at UHNM and the one million patients we care for each year. Thank you for running that extra mile, pedalling through the rain, leaping out of that aircraft or wading through mud. Thank you for talking to friends, family, colleagues and strangers about why you are fundraising and asking them to support you. Thank you for making a difference to our hospitals, you make them the outstanding places of care they are.

Much our income comes from legacies and we are really grateful to the generosity of those who take the time to remember us in their will in order to benefit future generations. This can be a difficult subject to broach but our team are here to answer any questions you may have.

I hope we can count on your continued support.

Review of the Year

It is thanks to the continued generosity of our supporters that UHNM Charity has received more than £1.3m in the last year supporting expenditure of more than £1.5m in the same period across all areas of care. The Charity income was received via donations, charitable activities, legacies and investment income. None of this would have been possible without the continued generosity of our many supporters.

Cancer

This year we funded a £17,500 Siterite 8 Console & Probe, which offers enhanced ultrasound equipment to clinicians. This enables the position of the peripherally inserted central catheter (PICC) to be identified within the patient's chest, improving the insertion success rate and eliminating the need for the patient to have a chest x-ray to establish that it has been inserted correctly. In addition, we funded Head & Neck cancer patient information videos to explain the treatment and care given to head and neck cancer patients. The films act as a replacement for traditional leaflets and helps patients' understanding and alleviates uncertainty about treatment.

Maternity



UHNM Charity supports many areas of the Maternity Centre to enhance care, including a £60k Affiniti Ultrasound system for the Neonatal Intensive Care Unit that provides state-of-the-art high quality images and improved quality of care. New bendy bumpers, covers and snuggle nests assist in the neurological and musculoskeletal development of pre-term babies who require the input of physiotherapy and other services for an extended period of time. The Forget-Me-Not Suite located in the Maternity Centre at Royal Stoke University Hospital provides an invaluable service to families when bereavement in pregnancy is an unwanted reality or an unexpected certainty. UHNM Charity plays an invaluable role in ensuring the facilities used by these bereaved parents are as comfortable as possible and less clinical in nature. This year we were pleased to work with the bereavement midwives to refurbish the lounge and bedrooms and, as part of the arts programme, to commission an artist to produce a bespoke art work for the corridor wall and windows.

Children's



UHNM Charity funded a High Frequency Chest Wall Oscillating Vest for Paediatric Intensive Care Unit & High Dependency Unit. Chest physiotherapists use a variety of treatments to facilitate the removal of chest secretions, but these are not always tolerated by children or are not as effective in complex patients, which results in a longer hospital stay. The £3,500 vest has been found to be beneficial to the patients with many different conditions. More than 100 patients have already benefitted from using the vest.

Education

To help ensure that our patients are served by the highest calibre staff, UHNM Charity assists by committing funds to enhance the education and development of UHNM staff. Such support is given to staff through grants, which will further develop their skills and knowledge and which has a direct benefit to patient care. However, grants are not given to training which is deemed essential for staff to perform their role.

Heart

The North Staffs Heart Committee became a dedicated fund within University Hospitals of North Midlands Charity and the sum of £620,000 was transferred from the former North Staffs Heart Committee Charity (NSHC), providing an incredible boost to the support we will be able to give to heart patients. We are currently working with the Heart Centre to identify a key project that will provide a legacy to the Committee's hard work. The committee, which was founded in 1979, provides funds to improve and advance cardiac care for the benefit of cardiac patients treated in this region. It was recognised with The Queen's Golden Jubilee Award in 2012.

Innovation and Research

UHNM Charity funded an electronic observation and monitoring system that captures real-time information. This provides clinicians with immediate, timely and accurate observation reports. The £750k investment means that patients can receive speedy interventions and the prevention of deterioration in their condition.

Donations given specifically for research are of great importance to the Charity. We seek to provide financial support for pioneering new research that has the potential to improve clinical outcomes for patients by finding new ways to prevent or treat complicated medical conditions or life-threatening illness. Ultimately leading to outcomes that will benefit patients locally, nationally and internationally. Grants have been awarded to a number of research programmes including, cancer, chronic asthma and the diagnosis of diabetes in patients referred for sleep apnoea and heart disease.

Arts

The Charity has continued to fund the arts programme, which uses visual and performing arts to enhance patient care and well-being, and the well-being of their loved ones, visitors and staff. This has included commissioning artists for bespoke works, including redevelopment of wards in County Hospital through a range of bespoke artwork, that not only improve the environment but assist in mobility and way finding for our most poorly and vulnerable patients.

Patient Environment

Patients' surroundings can have a significant impact on how they feel, which in turn can influence their recovery. A positive, welcoming environment means so much to patients and the Charity supports improvements through investment in arts, additional facilities and patient's comforts, which all add to a patient's experience. UHNM Charity funded a greenhouse for the hospital gardeners so they can grow the plants and flowers that make our hospitals a more welcoming place for our patients and visitors.



Our Charity

UHNM Charity is the official NHS Charity for both hospitals operated by University Hospitals of North Midlands NHS Trust – Royal Stoke University Hospital and County Hospital, Stafford. As such, we touch the lives of everyone in the North Midlands and beyond, no matter their age, or condition. Our wish is for our patients to receive the best care in the best possible environment.

Each year we invest in key areas such as equipment, research, patient and family support, staff training and transforming our two hospitals into more comfortable and welcoming environments. The core mission of the Charity is to enhance the care and treatment of patients accessing NHS services in the North Midlands, by supporting high priority areas which are beyond the scope of government funding.

In setting our objectives and planning our activities the Corporate Trustee Board has given serious consideration to meeting our public benefit commitment and to the enhancement of the care of patients through:

- enhancing the quality of patient care
- improving the environment for patients, visitors and staff
- supporting NHS staff development to enable them to provide excellent clinical and patient-centred care
- providing funding for pioneering research with the potential to impact directly on the treatment and wellbeing of patients.
- funding state-of-the-art equipment that improves outcomes for patients.

To achieve these objectives UHNM Charity operates a transparent grant making process. All UHNM NHS Trust staff, from across both hospitals, can apply for funding to provide additional equipment, facilities, staff training and research to what the NHS would normally fund. Our plans to deliver this funding include:

 encouraging UHNM NHS Trust to submit funding applications and to identify new facilities, training, equipment that the Charity can provide. This has been achieved by Charity staff meeting with key staff and Fund Advisers; and through the submission of charitable funds spending plans.

 raising income to provide the new facilities, training and equipment by supporting patients, members of the public, UHNM NHS Trust staff and organisations in their fundraising.

In line with our investment policy surplus monies not required to meet immediate commitments are placed in ethical and social investments to create additional income to achieve the charity objectives in the future. The staff working for the Charity are employed by UHNM NHS Trust. UHNM Charity reimburses the NHS Trust for these costs.

County Hospital, Stafford, Fundraising Appeal

Our £600,000 appeal was launched in August 2017 to improve areas of County Hospital. The Appeal is set to run until March 2019 and huge progress has been made to the total. The fund will create a £200k garden for cancer patients and overhaul a room for bereaved families. The bereavement room is used by those saying a final goodbye to their loved ones or for families of seriously-injured patients having to spend a long time waiting.

Money has already been raised and put towards a number of projects to enhance wards and treatment areas, including brightening up walls with paintings, stencils and portholes and creating sitting areas to help dementia patients. Staff also wanted to brighten up the Acute Medical Unit and Outpatients departments, improving lighting, signs and other facilities. Claire MacKirdy, director of operations at County Hospital, said: "The charity exists to support both hospitals to make life better for patients. Work done so far is amazing."

Stafford 10K

UHNM Charity's County Hospital, Stafford, Fundraising Appeal was chosen as the charity partner for the Stafford 10k. The event, which takes place in September, has quickly established itself as one of the 'must do' road runs in the area since it began in 2016. All those who signed up to represent the Appeal fundraised to provide a range of enhancements at the hospital.

Naomi Duggan, Director of Communications, said: "We're obviously delighted that our County Hospital, Stafford, Fundraising Appeal has been chosen as the charity partner for the past two years. The Stafford 10k is now one of the most eagerly anticipated events on the calendar and both our staff and supporters have really taken it to their hearts. One of the spaces they are fundraising for will transform the Oncology, Haematology Treatment Unit's courtyard so that patients will be able to leave the clinical area and enjoy a very tranquil setting."

Baby Hip Scanner

UHNM Charity funded a state-of-the-art hip scanner, which is changing the lives of babies in Stafford. The £30,000 scanner, funded by the charity, will ensure our county's tiniest patients receive expert treatment at County Hospital, Stafford, instead of regularly attending clinics at Royal Stoke University Hospital. Patients can be born with a 'clicky hip', or developmental dysplasia of the hip. It affects 3% of new born babies and means the hip is not in the socket correctly.

Garden and Fresh Hair Wigs & Wellbeing Salon



Cancer patients and those with blood disorders will soon be able to spend their time being cared for in a new garden. Patients often spend several hours in hospital, every few weeks, receiving treatments like chemotherapy. This can involve them sitting in a chair for up to seven hours with little to entertain or to distract them. Our Appeal will fund a garden, a sanctuary away from the clinical environment during their treatment. It will be a calming, soothing place where they can relax.

In addition, building on the success of the Fresh Hair Wigs & Wellbeing salon at Royal Stoke University Hospital, the Charity was delighted to fund a new salon and service in the new unit at County Hospital. Now patients who have suffered hair loss can choose a wig or bandana to suite them in a purpose built environment.

Outpatients

More than 125,000 local people a year attend the Outpatients department at County Hospital. Some will be examined and given treatment before being admitted to the hospital at a later date, others may attend for follow-up treatment after being discharged from hospital or being referred by their GP. Our appeal has made it easier for patients to find their way around the department and will improve the environment greatly.

Family support Charity after miracle recovery

A woman who suffered six cardiac arrests in six weeks stunned doctors by making a full recovery. Jane Kent collapsed at a family party in July 2017 and had to be rushed to Royal Stoke University Hospital to be cared for in Critical Care for six weeks. The 52-year-old, who together with her husband, friends and family raised money for UHNM Charity, and is now back at work having made a near full recovery.

Husband Gareth Kent said that he'd had 'the chat' so many times with clinicians that Jane's recovery was a minor miracle. He said: "Jane was in an induced coma for five weeks and there were various attempts to wake her up. She's almost back to who she was. We can't thank the staff enough.

"We got Jane home and we just wanted to give something back to the team that had helped her. Jane isn't the only one we know who has been treated in Critical Care. We're season ticket holders at Crewe Alex and we know some people who are in bands so we just put the two together and organised a charity night with an auction. So many people were so generous that night, especially the football club, their staff and the people who played in the bands."

In total Jane and Gareth raised nearly £6,000 to support patient experience in Critical Care. The money will be used to buy equipment that will support the comfort of patients and their relatives during what can be long stays on the unit.

Dr Stephen Krueper, Consultant Intensivist, said: "Our Critical Care team were delighted to hear about Jane's fantastic recovery. It is motivating for us to see that the very difficult and challenging time on Critical Care that Jane and Gareth went through last year when Jane's life was hanging on a thread was worth it. We are very grateful for the generous donation to our Unit, which will be used for the benefit of other patients now."

Inspirational Dad running the extra mile for Neonatal Unit



Dad Antony Perrins raised vital funds for the Neonatal Intensive Care Unit (NICU) at Royal Stoke University Hospital by running an incredible ten 10k races in ten months. Tiny Oliver Charlie Perrins was born at just 29 weeks, weighing 2lb 13 ounces. After 81 days spent in the Neonatal Unit this little miracle went home. As a small way of thanking all of the staff, who cared so wonderfully for this precious little boy, his dad, Antony undertook this truly daunting challenge.

Antony, said: "All the staff on the Neonatal Intensive Care Unit have been amazing and without all of their help and support we wouldn't have our little miracle with us today. We were delighted that after 81 days in hospital we finally had Oliver home and we can start our lives as a family at home together. As a small way of thanking all of the staff at Royal Stoke NICU, I wanted to give something back by raising money to developmental care boundaries and for muslin bunnies that can make the baby's stay in NICU a more comfortable experience."

Lynn Keilty Woolcock, Neonatal Unit Matron, said: "We are very lucky to receive fantastic support from UHNM Charity and the many fundraisers who have helped equip our unit with some fantastic facilities for our patients and their families. It's brilliant that little Oliver has been able to go home after his time on the unit. I would like to thank Antony for his efforts and all the staff on the unit cheered him on. We are very grateful for Antony's support, which will benefit other patients and their families during their stay."

Trustees' Report for the year ended March 2018

The Board of Trustees is pleased to present the UHNM Charity (Charitable Fund) Annual Report together with the Audited Financial Statements for the year ended 31 March 2018. These accounts have been prepared by the Trustees in accordance with the Charities Act 2011 and have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" (FRS102) in preparing the annual report and financial statements of the Charity.

Legal Structure

University Hospitals of North Midlands NHS Trust is the corporate trustee of the funds held on trust under paragraph 16(1)C of Schedule 2 of the NHS and Community Care Act 1990. University Hospitals of North Midlands Charity was registered as an umbrella charity with the Charity Commission on 18 March 1996 under registration number 1054889, by Model Declaration of Trust. It has no subsidiary companies.

Management of the Charity

The Trust Board of University Hospitals of North Midlands NHS Trust (the Trust) is the Corporate Trustee of UHNM Charity and holds assets belonging to the Charity. All voting Executive and Non-Executive Directors of University Hospitals of North Midlands NHS Trust are Trustees of the Charity and receive training through Board Development sessions. The directors of the Corporate Trustee are not Trustees, however, they act on behalf of the Corporate Trustee. The Charity is separate from the Trust and independent of it, but the Trustees always aim to work closely with the Trust. The Corporate Trustee can delegate certain powers to agents and/or employees but will always retain the ultimate responsibility for the management of the Charity.

The Charitable Funds Committee will oversee the Charity's operation on behalf of the Corporate Trustee. The Committee will apply scrutiny and constructive challenge to the Charity's financial information and systems of control, including the Annual Accounts, to provide assurance to the Corporate Trustee Board that the administration of charitable funds is distinct from its exchequer funds and compliant with legislation and Charity objectives. The Charitable Funds Committee meet and report to the Board, which approves major decisions and remains responsible for the activities of the Charity. The day-to-day management of the Charity is overseen by the Director of Communications.

Objectives

The main objectives of the Trustees are to accept, hold and administer any property on trust for any charitable purpose or purposes relating to the National Health Service, wholly or mainly for the service provided by University Hospitals of North Midlands NHS Trust. The funds of the Charity accumulate from the receipt of donations and legacies together with the returns on investments. The funds are used above basic NHS provision to enhance the care of patients through the provision of new or enhanced facilities, state of the art equipment, and innovative medical research and skilled staff (through welfare, learning and development).

Investment Policy

Surplus monies not required to meet immediate commitments are currently invested in the COIF Charity Funds, which are common investment and deposit funds established under sections 24 and 25 of the Charities Act 1993. The administrative functions for the COIF Charity Funds have been delegated to CCLA, whose ethical and social investment policies support the UHNM Charity's own investment policies support the UHNM Charity's own investment policy. The portfolio has performed in line with the overall stock market conditions during the financial year with performance continually monitored by the Charitable Funds Committee.

Reserves Policy

The Charity has a policy of holding reserves to ensure that normalised expenditure has a three year cover. This policy is reviewed periodically.



Risk Policy

The major risks to which the Charity could be exposed have been identified and considered. They have been reviewed and systems developed to diminish those risks. The most significant risks have been identified as:

- 1. Losses from a fall in the value of the investments due to volatility in world markets
- 2. Fraud

The Committee is satisfied that the Charity's Investment Policy together with robust financial procedures including the regular monitoring of investments minimises these risks. Income and expenditure is monitored in total on a quarterly basis to avoid unforeseen calls on reserves should investment income reduce.

Expenditure Approval Policy

As a grant making charity, each application is considered on its own merit and appropriateness against the Charity and fund objectives (if restricted), and it must comply with the Charity Commission funding criteria and UHNM Charity Policy. All grant applications are subject to approval by the NHS Trust (to ascertain they can meet their on-going liabilities) and the Corporate Trustee Board or its appointed officers. All research grants awarded will be approved by the ethical committee and results must be made available within the public domain.

Statement of Trustees' Responsibility The Trustees are responsible for:

- keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the funds held on trust and to enable them to ensure that the accounts comply with the requirements in the Charities Act 2011 and those outlined in the directions issued by the Secretary of State;
- establishing and monitoring a system of internal control; and
- establishing arrangements for the prevention and detection of fraud and corruption.

The Trustees are required under the Charities Act 2011 and the National Health Service Act 1977

to prepare accounts for each financial year. The Secretary of State, with the approval of the Treasury, directs that these accounts give a true and fair view of the financial position of the funds held on trust, in accordance with the Charities Act. In preparing those accounts, the Trustees are required to:

- select suitable accounting policies and apply them consistently;
- observe the methods and principles in the Charities SORP 2015 (FRS102);
- make judgements and estimates which are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the accounts.

The Trustees confirm that they have met the responsibilities set out above and complied with the requirements for preparing the accounts. The financial statements set out in this document have been compiled from and are in accordance with the financial records maintained by the Trustees.

In exercising their powers and duties the Trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission.

Related Party Transactions

University Hospitals of North Midlands NHS Trust is a related party. During the year none of the Trustees or members of the key management staff or parties related to them has undertaken any material transactions with the Trust outside their role as employees of the Trust. Details of remuneration paid to Trustees in their roles as employees of the UHNM Trust can be found in the remuneration report section of the Trust's annual report and accounts.

Financial position at 31 March 2018

The total incoming resources available in 2017/2018 amounted to £1,300,000, a reduction of £769,000 on the financial year 2016/17. Expenditure during the year, in grants made to 416 projects, amounted to £1,578,000. The overall fund balances decreased in 2017/2018 by £162,000.

Notes to the Financial Statements

1 Accounting Policies

1.1 Basis of preparation

UHNM Charity has prepared its financial statements that comply with SORP 2015 (FRS102) for the year ended 31 March 2018. The charity constitutes a public benefit entity as defined by FRS102. The accounts (financial statements) have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) issued on 16 July 2014, and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011 and UK Generally Accepted Practice as it applies from January 2015.

1.2 Income recognition

All incoming resources are included in full in the Statement of Financial Activities as soon as the following three factors can be met:

i) Entitlement - arises when a particular resource is receivable or the charity's right becomes legally enforceable;
ii) Probable - it is more likely than not that the economic benefits associated with the transaction or gift will flow to the charity

iii) Measurement - when the monetary value of the incoming resource can be measured with sufficient reliability

1.3 Legacies

Legacies are accounted for as incoming resources once the receipt of the legacy becomes probable. This will be once confirmation has been received from the representatives of the estates that payment of the legacy will be made or property transferred and once all conditions attached to the legacy have been fulfilled.

1.4 Expenditure recognition

The funds held on trust accounts are prepared in accordance with the accruals concept. All expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party.

a) Cost of raising funds

The cost of generating funds are the costs associated with generating income for the funds held on trust.

b) Grants payable

Grants payable are payments, made to third parties (including NHS bodies) in the furtherance of the funds held on trust's charitable objectives to relieve those who are sick. They are accounted for on an accruals basis where the conditions for their payment have been met or where a third party has a reasonable expectation that they will receive the grant. This includes grants paid to NHS bodies and relevant allocation of support costs. The majority of grant payments made by the charity have been made to University Hospitals of North Midlands NHS Trust.

c) Voluntary income and Governance costs

These are accounted for on an accruals basis and are recharges of appropriate proportions of costs from University Hospitals of North Midlands NHS Trust.

1.5 Structure of funds

Where there is a legal restriction on the purpose to which a fund may be put, the fund is classified in the accounts as a restricted fund. Funds where the capital is held to generate income for charitable purposes and cannot itself be spent are accounted for as endowment funds. Other funds are classified as unrestricted funds. Funds which are not legally restricted but which the Trustees have chosen to earmark for set purposes are classified as designated funds. The major funds held are disclosed in note 9.

1.6 Investment Assets

Investment assets are shown at market value.

1.7 Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and opening market value (or date of purchase if later). Unrealised gains and losses are calculated as the difference between market value at the year end and opening market value (or date of purchase if later).

1.8 Change in the Basis of Accounting

There has been no change in the basis of accounting during the year.

1.9 Prior Year Adjustments

There has been no change to the accounts of prior years.

1.10 Pooling Scheme

An official pooling scheme is operated for investments held by the Charity. The scheme was registered with the Charity Commission on 31st March 1998.

1.11 Related party transactions

During the year none of the Trustees or members of the key management staff or parties related to them has undertaken any material transactions with the University Hospitals of North Midlands NHS Trust outside their role as employees of the Trust. During the year none of the Trustees has received any further remuneration or reimbursement of expenses for the provision of their services as a Trustee of the Charitable Fund outside their role as employees of the Trust.

The charitable trust has made revenue and capital payments to the University Hospitals of North Midlands NHS Trust where the Trustees are also members of the Trust Board. In year these payments amount to £1,757,865 (2016/17: £2,205,821). Outstanding at the year end was a balance of £1,010,851 (2016/17: £349,683) of which £1,014,678 is included within creditors falling due within one year, with the remaining £3,827 included in debtors.

1.12 Commitments

Applications for expenditure are treated as commitments as soon as the necessary approval is granted and recipients have received confirmation by the year end in order to create a constructive obligation. The Trustees of these funds will endeavour to encourage spending plans within the forthcoming year.

1.13 Going concern

The financial statements have been prepared on a going concern basis as the trustees believe that no material uncertainties exist.
